Directions from Interstate 94: From I-94 exit at Cretin/Vandalia Exit and proceed south on Cretin Avenue. Turn east (or left, up a small hill) on Randolph Avenue. The campus will be on your right, but stay on Randolph until Fairview Ave. Turn right on Fairview and go a short distance to Gate 4, where you will turn right and continue towards a large parking lot. The Butler Center is a short walk from the lot in the same direction you were heading when you turned into the campus.
